REGULAR MEETING EFFINGHAM WATER AUTHORITY

The regular meeting of the Effingham Water Authority was held on Monday, January 14, 2019, at 5:30 P.M., at The Effingham Public Library, 200 N. Third Street, Effingham, Illinois. The meeting was called to order by Chairman Brown. Roll call was taken, with the following trustees present: Rob Brown, Chris Kabbes and Jim Boos.

Mr. Boos moved to approve the minutes of the regular meeting dated 11/12/18. Motion seconded by Mr. Kabbes, motion carried.

Mr. Boos moved to approve the treasurer's report. Motion seconded by Mr. Brown, motion carried.

Mr. Kabbes moved to approve the list of bills for November and December 2018. Motion seconded by Mr. Brown, motion carried.

Mr. Boos moved to approve the Audit Report for FY 2017-2018. Motion seconded by Mr. Brown. Mr. Brown reminded that Mike Johnston recommended having budgets for all accounts not just the tax account. The office manager and Mike Dirks are working on budgets.

Replat of Wente & Wenthe No. 2 Subdivision, Lot 63 & Lot 64:

Tom Kern addressed the Board regarding a survey of replatting of Lot 63 and 64. The tenants have come to a contractual agreement regarding the replat. Tentative agreement was given to proceed with the replatting. Mr. Siemer gave guidance as to how Mr. Kern was to continue with getting the replat and new description of the properties. Mr. Brown moved to approve. Motion seconded by Mr. Boos, motion carried.

Campground Improvement Agreement:

Scott Conant addressed the Board regarding reimbursement for improvements for the year 2017. As per the Amendment to Lease recorded 02.07.2014, the reimbursement would be for the first two (2) years (2014 and 2015) and consider a third year (2016) on the same terms. Mr. Brown stated that this offer is offered to new tenants where major renovations/repairs are necessary and usually not extended; however, the Board would be open to listen to a presentation from Mr. Conant at a future meeting.

Marina Sub-Lease:

Brian Larson presented the Board with a Sub-Lease dated January 1, 2019 with Schultz's Establishments, LLC and Deb's

Catering, Inc. for one (1) year. Mr. Larson also discussed changes and renovations that may be implemented this year.

Currently there are two (2) scheduled entertainments:

Moccasin Creek

June 20 - June 24, 2019

Summer Sundown

September 14 - September 15, 2019

He mentioned that a Blues Festival may be in the works.

There will be some construction changes at the stage area including having seven (7) flushable toilets.

Mr. Brown reported that the City of Effingham used 22 million gallons of water in the month of November and 26 million gallons in the month of December. Total usage for the year was 434 million gallons with the highest consumption month May with 55 million gallons

Superintendent's Report:

Mike Dirks stated that the water was 1'' below normal pool level and that he processed 1 permit.

Office Manager's Report:

Sue Verdeyen reported that she processed 3 lease transfers in November (1 buyer backed out) and 6 lease transfers in December (5 of which were just name changes).

Committees:

Tom Ryan, on behalf of Parks and Recreation, reported that ground has been broken for disc golf, cutting the underbrush and grinding 6" and smaller trees. He has been invited to the Illinois Park Conference in Chicago where he will be able to make contacts for future assistance in the project.

Brad Hastings reported that Bob Einhorn would be taking over for the Water Quality Committee and that they are reorganizing.

He also reported on behalf of the Boating Committee. At their committee meeting they discussed permanent anchoring of buoys, lighted buoys and adding additional sticker to put with the Boat Stickers addressing the recurrent violations and putting up signage with the same information. Mr. Hastings suggested trying a few permanent anchoring of buoys at first. If lighted buoys are approved, they will seek funding.
