Mr. Brown reported the City of Effingham drew, from the lake, just over 42 million gallons of water in September.

Mr. Brown addressed those present in regards to the new leaf vac and the process. All leaves will need to be raked to the edge of the yard adjacent to the road. No sticks, branches, animals or trash should be included in the leaves. Service will be provided to leaseholders later in October.

APPROVE TAX LEVY

TENT CAMPING PERMITS

Mr. Brown referred to current regulations in regards to tent camping. The decision was made to table the discussion until Chairman Boos is present at next month's meeting.

MISCELLANEOUS

Attorney Siemer reported he has received phone calls in regards to notices for adjoining property owners when a property is in foreclosure. The notice of sale is published in the paper and that is considered to be the notice.

Jeff Niebrugge spoke on behalf of the fishing committee in regards to the habitat structures that will be placed on the lake on Wednesday October 26th. The Department of Natural Resources will be assisting in the installation and within two years the structures will be invisible.

Tom Ryan spoke on behalf of the Park and Recreation Committee. The Park and Recreation Committee announced that the Lake Sara Forever Foundation has reached an agreement for the procurement on the Beach lease rights for future incorporation into a peninsula wide park.

Mr. Dirks reported that the lake is seven inches below normal pool and he has issued 6 building permits.
